SUMMARY

I am a (full) professor of law at the University of the Witwatersrand in Johannesburg, South Africa, where I have taught various public law subjects, at both undergraduate and postgraduate levels, since 1998. I have substantial experience of strategic academic leadership at school and faculty level, particularly in research management and postgraduate studies. I further have extensive experience in curriculum development at undergraduate and master levels and a strong record of postgraduate supervision and mentoring, including 11 PhDs supervised to successful completion.

I hold a PhD (on the right to health) from the University of the Witwatersrand, and LLM, LLB and BLC degrees (all cum laude) from the University of Pretoria, South Africa. Over the course of my academic career, I have published two monographs and more than 80 peer reviewed journal articles or book chapters. I hold a prestigious “B2” rating from the South African National Research Foundation and, in 2024, was joint recipient of the University of the Witwatersrand’s highest research accolade, the Vice Chancellor’s Research Award. My current research programme examines how public law, constitutionalism and human rights are being reshaped by urbanisation and contemporary governance challenges, with particular attention to the evolving role of cities in responding to democratic, social and environmental pressures. My work has appeared in leading legal and urban studies journals around the world, alongside highly regarded journals in development studies, African studies and political science. My work is regularly cited by academics, courts and policy institutions, and I am actively engaged in international research networks and collaborations.

RESEARCH

Research and publication history:

I have written on a wide range of public-law topics but have in recent years focused on cities and human rights, socio-economic rights, public health, urban law and urban governance. I am the author of two sole-authored academic monographs as well as of more than 80 peer-reviewed academic journal articles or book chapters. My articles have appeared in highly rated law journals in South Africa and internationally, as well as in highly rated journals in urban studies, development studies, African studies and political science. I have also published working papers, op-eds and blog posts on various topics relating to urban governance, constitutionalism and human rights. My research is predominantly desk-based but I am also familiar and comfortable with both qualitative and quantitative research methodologies.

Recognition / awards:

University of the Witwatersrand Vice Chancellor’s Research Award:

I was the joint recipient of the 2024 Vice Chancellor’s Research Award, the University of the Witwatersrand’s highest research accolade which purports “to acknowledge the achievements of an exceptional Wits scholar who has demonstrated high levels of research excellence over a sustained period”.

My work has been extensively cited in academic publications - on 1 June 2026 my Google Scholar h-index was 19 from 1499 citations with an i-10 index of 37.
